**HOLLAND SYMPHONY ORCHESTRA (HSO) CREATED CONCERTS, EDUCATIONAL PROGRAMMING AND COLLABORATIVE EVENTS FOR THE FISCAL YEAR 2020-2021. EIGHT CONCERTS WERE PROGRAMMED, AND TICKETS WERE SOLD TO INCLUDE: 3 CLASSICAL, 1 HOLIDAY, 1 FAMILY, 1 CHAMBER ORCHESTRA, 1 TICKETED POPS AND 1 FREE POPS. 500 SEASON TICKETS WERE SOLD. DUE TO THE STATE OF MICHIGAN AND VENUE SHUTDOWNS CAUSED BY THE COVID 19 PANDEMIC, ALL HSO CONCERTS WERE POSTPONED UNTIL 2021-2022. 69% ROLLED OVER THEIR TICKETS TO THE NEXT YEAR, 27% DONATED THE COST OF TICKETS AND 4% WERE REFUNDED. FOUR VIRTUAL CONCERTS WERE RECORDED ON YOUTUBE WITH NO AUDIENCE AND SENT TO OUR SEASON TICKET HOLDERS AND PARENTS OF OUR YOUTH ORCHESTRA STUDENTS FREE OF CHARGE.**
